The 28-mile SB2S corridor is one of the most congested and heavily used corridors in San Diego County. The I-805, for example, serves approximately 200,000 vehicles per day and

can have significant delays during peak periods. Major transportation facilities that pass through the SB2S study area include 1-5, i-8, I-805, SR 52, SR 54, SR 94, SR 905, major arterials, and the Bayshore Bikeway. Existing transit services include the COASTER, the Trolley, multiple Rapid lines, and more than

SOUTH BAY TO SORRENTO COMPREHENSIVE MULTIMODAL CORRIDOR PLAN (CMCP)

SANDAG and Caltrans District 11 announce the release of the Draft South Bay to Sorrento Comprehensive Multimodal Corridor Plan (CMCP).

The Draft South Bay to Sorrento CMCP is the culmination of a data-driven process that utilized extensive engagement and input from stakeholders from late 2020 through 2022. The CMCP addresses the current and future multimodal needs of the corridor, which includes the diverse cities of San Diego, Chula Vista, Coronado, National City, and Imperial Beach. In total, 331 transportation strategies were proposed for implementation through 2035.
